Therapeutics

40 5-day and 3-day oral prednisolone did not differ for asthma control in children who had acute asthma exacerbations

41 Review: exercise helps relieve pain in patients with hip osteoarthritis

42 Review: inhaled anticholinergics increase risk of major cardiovascular events in COPD

43 Tiotropium reduced exacerbations but not rate of FEV₁ decline in patients with COPD using other respiratory medications

44 Ondansetron reduced the need for intravenous hydration in children with acute gastritis/gastroenteritis and dehydration

45 Mothers were less likely to be depressed after a structured behavioural intervention for infant sleep problems

46 Aspirin plus extended-release dipyridamole and clopidogrel were similarly effective for preventing recurrent stroke

47 Telmisartan did not prevent recurrent stroke or major cardiovascular events

48 Rosuvastatin prevented major cardiovascular events in people with elevated C-reactive protein

49 Review: less than maximum doses of ACE inhibitors lower BP to near maximum levels in hypertension

50 Specific oral tolerance induction increased tolerance to milk in children with severe cow's milk allergy

51 In high-risk adolescents, CBT reduced depression at 6 months more than assessment alone but did not differ from bibliotherapy or supportive-expressive therapy

52 Review: some computerised cognitive-behavioural therapies are effective for treating mild-to-moderate depression

53 Review: some evidence shows that pelvic floor muscle training reduces urinary incontinence in pregnant and postpartum women at ≤ 12 months

54 Laparoscopic surgery was more effective than medical management for GORD disease

55 Influenza immunisation during pregnancy reduced influenza in infants and respiratory illness in mothers

56 Review: C-reactive protein has moderate diagnostic accuracy for serious bacterial infection in children with fever

Prognosis

57 Review: 1-year risk of previously undiagnosed cancer is 6.3% in patients with newly diagnosed venous thromboembolism

Aetiology

58 Review: head covering is associated with increased risk of sudden infant death syndrome

59 Review: D-dimer concentrations predict risk of recurrent VTE after anticoagulant therapy is stopped
