Therapeutics

- 132 Topical antibiotic therapy is superior to systemic antibiotics for acute tympanostomy tube otorrhoea, but may not be necessary for all children
- 133 Electronic cigarettes are at least as effective as nicotine patches for smoking cessation
- 134 Cytisine is effective for smoking cessation: should clinicians use it?
- 135 Omalizumab decreases exacerbations and allows a step down in daily inhaled corticosteroid dose in adults and children with moderate-to-severe asthma
- 136 Interspinous process device versus standard conventional surgical decompression for lumbar spinal stenosis results in increased reoperation rates and costs without improving patient outcomes
- 137 Dual antiplatelet therapy in recurrent stroke prevention: do the benefits outweigh the risks?
- 138 Bariatric surgery produces greater weight loss and improvements in medical conditions than non-surgical treatment of obesity
- 139 Insufficient evidence exists to evaluate effects of blood transfusions and iron therapy for treatment of anaemia in patients with heart disease—erythropoietin agonists do not improve outcomes
- 140 The value of vitamin E as a treatment for Alzheimer's disease remains unproven despite functional improvement, due to a lack of established effect on cognition or other outcomes from RCTs
- 141 Arthroscopic partial meniscectomy provides no benefit over sham surgery in the setting of isolated degenerative medial meniscal tears without osteoarthritis
- 142 An 'all-human' diet decreases days of parenteral nutrition compared with formula in premature infants
- 143 Tight glycaemic control does not improve mortality or morbidity in critically ill children

Prevention

- 144 No consistent evidence to date that prenatal or postnatal probiotic supplementation prevents childhood asthma and wheeze
- 145 Mailed invitations for colorectal screening are effective in increasing screening participation in uninsured adults with faecal immunochemical testing: the preferred screening modality

- An intensive outpatient lifestyle modification programme improves measures of glycaemia in obese youth
- 147 Brief, patient-centred risk-reduction counselling at the time of a rapid HIV test does not affect subsequent acquisition of sexually transmitted infections
- 148 Combined HPV and cytology better than cytology for protection against cervical cancer
- 149 Extensive scheduled CT and CEA follow-up are equivalent in detecting recurrent colorectal cancer that is surgically treatable with curative intent, and superior to minimal follow up
- 150 Lung cancer screening with low-dose CT (LDCT) is ready for prime time in the USA

Diagnosis

- **151** Voided midstream urine culture is a good test for acute cystitis in premenopausal women
- 152 Seven days of non-invasive cardiac monitoring early postischaemic stroke or TIA increases atrial fibrillation detection rate compared with current guideline-based practice

Prognosis

- 153 Digoxin initiation is associated with lower risk of all-cause readmission after hospitalisation for heart failure
- 154 First trimester fetal size is inversely and modestly associated with cardiovascular risk factors in childhood

Aetiology

- 155 Mediolateral episiotomy significantly reduces the risk of obstetric-associated anal sphincter injury (OASIS) in women who deliver via vacuum extraction
- Migraine is a marker for risk of both ischaemic and haemorrhagic stroke
- 157 In the absence of diagnosed concussion in collegiate contact sport athletes, a relationship is suggested between the effects of head impact exposure, white matter diffusivity measures and cognition

Quality improvement

- 158 Effect of communication training on patient, family and healthcare provider outcomes: missing links
- 159 Women with HIV infection on antiretroviral therapy with low viral loads can safely opt for vaginal delivery in the absence of obstetrical risk factors
- Physician antibiotic prescriptions for skin infections in the outpatient setting are often unnecessarily long and include unnecessary antibiotics
