## Therapeutics

- 210 Intensive glucose-lowering results in increased cardiovascular mortality in younger but not older individuals with type 2 diabetes
- **211** Oseltamivir and zanamivir have limited effect on symptoms and do not reduce hospitalisation or serious complications of influenza
- **212** Lactobacillus reuteri is an effective option for the prevention of diarrhoea in preschool children but may not be cost-effective in all settings
- **213** Individualised pelvic floor muscle training is an effective conservative treatment in women with pelvic organ prolapse
- 214 Calcium channel blockers are effective as first line for tocolysis in the management of preterm labour
- **215** Study concludes *L. reuteri* not effective for infant colic, but findings may be limited by participants' heterogeneity
- **216** Sham treatment shows similar effects on pain and function compared to a multimodal physiotherapeutic intervention programme in patients with painful hip osteoarthritis
- 217 Induction of labour decreases a woman's chance of caesarean delivery when compared with expectant management
- **218** ACE inhibitors are associated with a reduction in all-cause mortality versus angiotensin II receptor blockers in patients with diabetes mellitus
- 219 Pro-vaccine messages may be counterproductive among vaccine-hesitant parents
- 220 At 15 years of follow-up, bariatric surgery, especially when performed within the first year, is associated with diabetes remission and reduced incidence of microvascular and macrovascular complications
- 221 Psychological therapies help reduce headache and non-headache pain in children and adolescents
- **222** Rate and rhythm control have comparable effects on mortality and stroke in atrial fibrillation but better data are needed
- 223 Ledipasvir/Sofosbuvir administration achieves very high rate of viral clearance in patients with HCV genotype 1 infection without cirrhosis, regardless of ribavirin co-administration or length of treatment

- 224 Questions linger over POISE-2 and perioperative aspirin management
- **225** Surveillance for hepatocellular carcinoma with ultrasound and AFP is associated with improvements in tumour detection, receipt of curative therapy and overall survival in patients with cirrhosis
- **226** Azithromycin associated with a reduction in 90-day mortality among older pneumonia patients, although a true clinical benefit is uncertain
- **227** Until questions on intraprocedural efficacy control, renal nerve distribution and predictors of BP response are answered, the interpretation of clinical trials on renal denervation will remain uncertain
- **229** RIVUR trial offers confirmatory evidence for a small but real benefit of antibiotics for UTI prevention in children
- **230** If pharmacotherapies for alcohol use disorders are effective, why are they underutilised?

## Diagnosis

- 232 Predictive values of GPs' suspicion of serious disease are high enough to warrant subsequent investigation
- 233 Improving malaria treatment by increasing access to accurate diagnostic tests: test results must guide treatment
- **234** The STONE score can help diagnose urolithiasis and decrease the use of CT scans
- **235** Prolonged cardiac monitoring after cryptogenic stroke superior to 24 h ECG in detection of occult paroxysmal atrial fibrillation

## Aetiology

- **236** Elective induction of labour is associated with decreased perinatal mortality and lower odds of caesarean section at 40 and 41 weeks
- 237 Maternal body mass index increasing above 20 is associated with increased risk of miscarriage, stillbirth, neonatal death and postneonatal death

### Harm

**239** Balancing competing risks: perinatal exposure to macrolides increases the risk of infantile hypertrophic pyloric stenosis

## **Quality improvement**

**240** A move beyond screening is required to ensure adequate healthcare response for women who experience intimate partner violence
